Code Compliance

As the new Communications Director, I have received many emails concerning code compliance. I would like to take a moment to review a few of the most common code compliance regulations. This list is by no means a complete list, but rather are some of the ones that the city considers "most common".

Maintenance of Fences/Walls: All walls or screen fences shall be maintained in a neat, solid, substantial and safe condition. No wall or screen fence shall be kept in a listing, damaged, or decaying condition.

Junked vehicles: Inoperable vehicle cannot be stored on private property in excess of 10 days.

Broken-down, junked vehicles should not be parked in yards, on the street or in any location that can be seen in ordinary public view. A fine may be imposed for this violation and the vehicle may be towed by the City and destroyed if, after notification, it is not repaired or removed from these locations.

Lot Maintenance: Property's weeds and grass not to exceed 12 inches and kept free of trash and rubbish.

Outside storage: Yards should not be used as storage areas for vehicles, building materials, tires, indoor furniture, appliances, boxes or other items. Outside storage is a violation of the City's zoning code.

Obstructions on City property or rights-of-way: Sidewalks, streets and other public rights of way must be kept free of obstructions. Overhanging tree limbs, basketball goals, fences, dumpsters, shrubbery or other obstructions in City-controlled rights-of-way are prohibited and must be removed by the owner of the abutting property.

Premises (Maintenance): Premises must be clear of trash, debris, and overgrown vegetation.

Storage (Outside): Storage bins, rooms, and areas shall not be used for accumulated garbage or refuse. Inflammable or combustible liquids or other materials may not be stored on the premises unless they are of a type approved for storage.

Trees (Dead): Maintaining a dead tree on private property is prohibited.

All of the above information was taken from the City of San Antonio website. The city has a very informative brochure which highlights some of the most common compliance codes and provides instructions on how to file a report with the city.
