SUBDIVISION SIGN

Based on the number of phone calls and emails that I have received, the subdivision sign at the entrance of our neighborhood is something that is very important to many of our residents. With that in mind our Landscaping Committee, Lori Chapa and Jerry Schott, worked for over 3 months meeting with multiple contractors to design an attractive and affordable sign for our neighborhood.

Unfortunately, the property owner does not want us to build a new sign on his property. So, as it stands now, the sign that is there now is what we have. We do not own any land at the entrance to our subdivision (for some reason the developers of our property did not provide for this when they developed our community).

We plan to maintain the current sign for as long as possible. Hopefully, at some point in the future, we can come to some understanding with the property owners on either side of our entrance.

Code Compliance Issues



We would like to take this opportunity to remind residents about some code compliance issues that have been noticed in our neighborhood. Please take a moment and read through this list and make sure that your property is


in compliance with city codes and regulations.

- Parking on the street that impedes the thoroughfare of the service vehicles coming from an alley onto a main street. These vehicles are large and cannot make the turns without damaging a vehicle that is blocking or damaging fences, irrigation system or easements.
- Junked or inoperable cars in public view.
- Failure to mow and care for lawns. (weeds higher than 12").
- Trees hanging low and obstructing vehicular passage and trimming of trees that block the walk ways. Residents are responsible for their trees and trees cannot overhang onto the sidewalk or street. The sidewalks need to have a 6 ft. clearance. Also note that any trees that are dead or have dead limbs are required by the city to be removed.

- Fence issues: Owners are responsible for maintaining their fences. This includes every type of fence for every home in our neighborhood. Please take a moment and look at your fence and make sure that it is in good
- Alleys: Residents are required to maintain their property AND any foliage, shrubbery, grass, etc. halfway into the alley/easement behind their property. For those who live along NW Military, residents are required to maintain the property behind any fences up to the concrete drainage area. Residents who live along the greenbelt are required to maintain your property out to your property line. For those who live along the old Voelker Lane path that leads to the Salado Creek walking path, you are required to maintain the rear of your property to midway into the path.

**Several Recent Incidents Have Prompted a Re-Run of This Article **

An Animal Care Reminder:



When walking your dog(s), please remember that they must be on a leash at all times, (regardless of their size or how well-trained they are). DOGS ARE NOT ALLOWED TO RUN FREE IN OUR NEIGHBORHOOD! Doing so is a violation of the San Antonio Leash Law (to say nothing of a danger to other residents and animals). Recently, multiple

requests have been made asking that the city crack down on residents who do not obey our leash laws. According to the San Antonio website (www.sanantonio.gov/animalcare), any resident can call 311 and request that an animal be picked up by the city. When doing so, a resident needs to note if the animal is:

Stray and/or injured

- Loose vicious (the animal(s) has a known owner and you can provide owner information)
- Stray vicious (unknown owner)
- Stray public nuisance (dog roaming, getting into trash etc, dog not vicious just a public nuisance)
- Regular stray (no owner, not causing problem just a stray)
- Stray traps (any animal in a live animal trap)
- Stray contained (an animal that is being contained in an area, i.e. pool area, backyard area, garage)

Landscaping Reminder

Please remember that any landscaping that you have that borders your sidewalk needs to be maintained. If you use mulch, stones, or pebbles along any part of your sidewalk, they must be kept up off the sidewalk so that other residents do not slip or trip on them. According to the city, every household is responsible for maintaining the sidewalk that runs along the front of their property. So please remember to keep your sidewalk clear of anything that may be a safety hazard.

NEIGHBORHOOD NEWS

At our recent NNOD meeting, Assistant City Manager Peter Zanoni presented the San Antonio FY 2012-2017 Proposed Bond Program Development. The city issues a proposed bond every 5 years, which covers a host of infrastructure projects. We will be voting on this new bond program in the May 2012 election. This issue is for a total of \$596 million and if passed, there will be no increase in the tax rate. More information may be found on-line at sanantonio.gov.

Pat Schneider, Capital Improvements Project Manager, made a presentation about the Phase III, Urban Ecology Center under development at Hardberger Park. The presentation included a powerpoint and large scale model of the center.


